



**APPLICATION FOR NINETY (90) DAY LICENSE
TRANSIENT MERCHANT, PEDDLER, COMMERCIAL SOLICITOR**

The applicant shall provide all of the following information. By completing this application, the applicant represents a full familiarity with Ordinance No. 308, any amendments, or successor ordinance regulating Transient Merchants, Peddlers and Commercial Solicitors. A fee shall be due in the amount of \$175 on behalf of the entity to whom the license is issued with the additional sum of \$125 for each person engaged in regulated business activity for the applicant, i.e., employees. The application must be fully completed, all required materials provided, all fees paid and the application reviewed and recommended for approval by the police department prior to issuance of any permit.

If door to door sales are anticipated, please provide the specific location area, including streets.

For applicant, please provide a current 2 x 2 photograph depicting a frontal face, head and shoulder view, clear and unaltered.

Please also provide a copy of a current and valid photo identification, issued by a state or governmental agency with date of birth and a clear and intelligible photograph of at least the head and shoulders for applicant, its general partner or principal.

I represent that all statements are true to the best of my knowledge and belief. I acknowledge that any or erroneous statements on this application or any attachments is a basis for denial of the requested license. Conviction of violating provisions of this ordinance or any similar ordinance or law, conviction of a felony or misdemeanor involving dishonesty, theft, breaking and entering, criminal sexual conduct, fraud and misrepresentation, deception or cheating shall also serve as a basis for non-issuance.
